

**RE: REPORT ON AN INVESTIGATION INTO ALLEGATIONS OF MALADMINISTRATION  
RELATING TO THE AWARDED OF A CONTRACT TO TRACKER NETWORK (PTY) LTD  
BY THE SOUTH AFRICAN POLICE SERVICES – REPORT NO.111 OF 2019/20**

1. Your letter dated 31 January 2020 and our meeting held on 19 February 2020, refers.

2. We record that we noted the concerns raised in your letter and without responding to the contentions raised therein, we are nonetheless acknowledging, without conceding, that some of your concerns are plausible.
3. To this end, we wish to record the following concerning the Report:
  - 3.1. The investigation related to the conduct of the South African Police Services (SAPS);
  - 3.2. The findings were made and directed at SAPS;
  - 3.3. The remedial action was directed at SAPS;
  - 3.4. No finding was made against Tracker. Any comment or finding which may create the impression that there was any impropriety on the part of Tracker is regretted. Specifically, the suggestion in paragraph (viii)(b)(aa) of the Report's executive summary and paragraph 6.2.1 of the Report that Tracker has improperly benefitted from the use of state resources is regretted. The Public Protector did not find any impropriety on the part of Tracker.
4. We trust that the above is in order.
